Passport: You must have a passport that is valid through September 2026. Delegation costs include the following amenities in the Dominican Republic: Group housing, all delegation meals, ground transportation, emergency medical and travel insurance, registration with the Dominican Ministry of Health and the US Embassy, interpreters, tips, and taxes. Our delegation fee also helps support patient follow-up care from local physicians and medications for primary care patients. Delegation costs <u>do not include</u> the following: airfare to and from city of origin, single-occupancy accommodations, passport fees, personal immunizations, phone or laundry charges, private transportation/interpreters, personal spending money, and/or items of a purely personal nature. Travel to and from the Dominican Republic: All volunteers are responsible for coordinating their own travel between their city of origin and Santo Domingo Las Americas International Airport, Dominican Republic. Note: Estimated airfare, depending on the city of origin, can be between \$400 and \$1400. Trip logistic information: All selected FMCI delegation members will receive an information travel packet from our Dominican Republic partner, One World Surgery, with more detailed information starting in October 2025.
